

FEES

TRANSFERS:

As from 1 October 2016, transfer of registered Cattle (Bulls and Females) between registered herds - \$30 per female transfer and \$50 per male transfer. A family Transfer rate \$5.00 per animal is also applicable.

Late Transfers - refer regulation 9.

30-60 days late \$10.00 penalty for transfer

61-90 days late \$20.00 penalty for transfer

Over 90 days requires Council approval and penalty to be applied.

Breeding History of Transferable Females:

When a female is sold as transferable, her full breeding history must be disclosed prior to sale. (This includes information regarding donor dam ET programmes.)

IMPORT FEES: \$150.00 per animal covers NZHA registry processing

EXPORT FEES: \$150.00 per animal covers NZHA registry processing

FEMALE FEES:

Cows

Female Fees are payable on all females (three years and over) that are 'alive' within the Association's records at the time of printing the Calf Entry forms with the females pre-listed.

Effective 1 November 2011, the Female Fee is as follows:

\$22.00 per cow for 1-50 cows in each herd

\$21.50 per cow for 51-100 cows in each herd

\$21.00 per cow for 101-150 cows in each herd

\$20.50 per cow for 151-200 cows in each herd

\$20.00 per cow for 201 plus

A rebate of \$1/animal will be made to breeders who return their Animal Disposal Lists on time. (applicable from October 1, 2016).

Heifers

A Female Fee of \$13.00 is also payable on ALL two year old females. If a breeder is calving two year olds then the office is to be advised in order that Calf Entry forms may include pre-listing of the younger females.

Effective 1 November 2011, the Two year Old Female Fee is as follows:

\$14.00 per two year old for 1-50 2yr old in each herd

\$13.50 per two year old for 51-100 2yr old in each herd

\$13.00 per two year old for 101-150 2yr old in each herd

\$12.50 per two year old for 151-200 2yr old in each herd

\$12.00 per two year old for 201 plus

(This is a net increase of \$3.00 per active female).

A rebate of \$1/animal will be made to breeders who return their Animal Disposal Lists on time. (applicable from October 1, 2016).

Note: Herds with registered and non-registered cattle recorded with NZHA, that for the purposes of fees will be treated as one herd with the sliding scale applied.

Billing of Heifer Fees

From 1 October 2013, the following billing process for heifers will occur Two year old fees will be billed at the same time as cow fees (October) AND will be due the same time as cow fees – Due 20 November.

1. Commercial cow female fee.

Fees for commercial cows are now aligned with registered cow fees – this means as from October 2012, the beginning of the NZHA financial year, a herd with both registered and non-registered Hereford cattle recorded with NZHA be treated as one herd with the one sliding scale being applied across all recorded females.

2. Female Reinstatement Fee

\$50.00 for each female reinstated having previously been removed by the breeder. (applicable from October 1, 2016).

NOTE: An Active Dam List (ADL) is forwarded to all breeders for updating prior to the Calf Entry forms being pre-listed.

Female fees become due and are payable once the Active Dam List has been completed and returned by the breeder, processed by Hereford Registry and calf entry forms have also been prepared. It is imperative for breeders to return their Active Dam List by the due date of 1st June. From this date all ADL totals will become billing totals and breeders will be liable for this amount. All breeders returning their ADL on time will receive a rebate of \$1/animal.

Terms of Trade New Zealand Hereford Association (INC) – Effective May 2012

Any member services provided by the NZHA are payable by the 20th of the month following date of invoice.

0-30 days	Current Account
31-90 days	Interest will be charged at a rate of 1.5% per month from date of purchase. The interest rate is reviewable by the Council. All office/registry processes are withheld until payment is received.
90 days & over	Interest will be charged at a rate of 10% per month once accounts become 90+ days overdue. A letter will be sent to each debtor giving seven days to pay and naming the date by which payment is required. If payment is still not forthcoming, the Association reserves the right to recover the debt through an agency. Debt recovery will be actioned at the debtors own cost.

These are our standard terms of trade, and if our account is not met within these conditions, we reserve the right to adjust or include the costs of collection of any unpaid portion of the account pursuant to the Fair Trading Act of 1986

REGISTRATION FEES - CALVES:

1. Embryo Transplant Calves out of pre-listed Hereford recipients or any other breed or cross breed recipients - Fee of \$18.50 payable.
2. All other calves - no fee payable.
3. \$1.00 surcharge applies for manual entry calf registrations.
4. Final date for calf registration – 30 April of year following year of calving.

NZHA CALF REGISTRATIONS

Calf registrations are due on the last day of April each year. i.e. for the 2016 calf drop, the last day for the registration of calves is April 30, 2017.

LATE CALF REGISTRATIONS

It is important for breeders to understand that the integrity of the NZ Herefords performance recording system/ data is jeopardised if compliance to calf registration deadline is not met.

ON -CHARGING OF HEREFORD REGISTRY TIME -

NZHA has an 'on charging' rate when a breeder utilises an excessive amount of Hereford registry time. This rate will be at \$42 per hour, or part charge.

PREFILLING OF DAYS TO CALVING SPREADSHEET

An optional service now available to Hereford breeders, on request from Hereford registry. Flat fee charge of \$50 per herd for the prefilling/ email service.

Herd numbers + animal numbers can be preloaded in an Excel spreadsheet by Hereford registry, which is then emailed to the breeder for completing all mating details for the season. This is then returned at ADL completion time for the accurate female listing to be loaded onto next season's Days to Calving spreadsheet.
