**FULL BREEDING MEMBERSHIP**

Any person taking an interest in Hereford cattle, or any company, or corporation INTENDING TO BREED HEREFORD CATTLE (or wishing to upgrade their NZHA membership), shall signify to the Council his or its desire to become a member, and who shall apply to become a member of the Association shall on approval by the Council, be admitted as a full breeding member and be entered on the Register of Members. An annual member shall pay on admission an **Entrance Fee of \$500.00 GST inclusive and a subscription of \$112.50 GST inclusive and thereafter an annual subscription of \$112.50 GST inclusive** or any other sum as the Council may from time to time prescribe. (Prospective Miniature Hereford Cattle breeders must apply for a full breeding membership of the NZ Hereford Association. Ensure the Miniature membership box is also selected.)

**ASSOCIATE MEMBERSHIP**

Any person, company or corporation taking an interest in Hereford cattle who shall signify to the Council his or its desire to become a member, and who shall apply to become a member of the Association and shall on approval by the Council, be admitted as an Associate Member and entered on the Register of Members. An Associate Member shall pay an **annual subscription of \$28.13 GST inclusive** or any such other sum as the Council may from time to time prescribe. (An Associate Member is unable to register cattle and shall not be entitled to vote at any meeting of the Association, nor to hold office in the Association, but shall receive regular newsletters, magazines and relevant information on the Association's activities.)

**YOUTH MEMBERSHIP**

Any person under the age of 25 intending to breed Hereford cattle or taking an interest in Hereford cattle. A Youth member shall pay an **Entrance Fee of \$112.50 GST inclusive and an annual subscription of \$28.13 GST inclusive** or any other sum as the Council may from time to time prescribe.

**OVERSEAS MEMBERSHIP**

Any person, company or corporation residing outside New Zealand intending to breed Hereford cattle or taking an interest in Hereford cattle. An overseas member shall pay an **annual subscription of \$16.88NZD GST inclusive** or any such other sum as the Council may from time to time prescribe (Postage fees / subscription available on request).

Procedures instituted for payment of NZHA accounts

<b>0-30 days</b>	Current Account
<b>31-90 days</b>	Interest will be charged at a rate of 1.5% per month from date of purchase. The interest rate is reviewable by the Council. All office/registry processes are withheld until payment is received.
<b>90 days &amp; over</b>	A letter will be sent to each debtor giving seven days to pay and naming the date by which payment is required. If payment is still not forthcoming, the Association reserves the right to recover the debt through an agency.

These are our standard terms of trade, and if our account is not met within these conditions, we reserve the right to adjust or include the costs of collection of any unpaid portion of the account pursuant to the Fair Trading Act of 1986
