## HELPFUL HINTS

(For joining members)

•Please provide at least two prefix options. Your prefix acts in a similar way to a surname. Animals are identified by their prefix, name and identification number. For example -

 Please note use of the words 'Farm, Stud, Herefords' is not necessary as part of your Prefix. For example, a suggested Prefix of Mt Bruce Farm would be accepted by Council as 'Mt Bruce'.

•A date of birth is necessary for all youth members.

•The transfer of sold animals is the responsibility of the vendor. The purchaser is responsible for the transfer fee.

 Breeding members are required and expected to complete and return herd records (eg. ADL's, calf returns) on time to allow accurate invoicing and registry inventory.

•Notification of the wish to resign from the NZ Hereford Association or an adjustment to your membership should be made in writing and any outstanding invoices must be settled before the resignation can be actioned.

•Fee structure - Upon joining the New Zealand Hereford Association, a one off entrance fee is payable in conjunction with the subscription. The subscription is payable annually thereafter. Female fees are charged annually (on a sliding scale for all registered three-year-olds and over) please refer to the herd book or the new member information pack for the full scale. A registration fee is also payable on all two-year-old females regardless of if they have calved or not.

Full details can be found on Page 11 of the new member booklet, which will be posted out upon receipt of membership application.

•An AHB number is a farmers Animal Health Board number, also known as a TB Free number. This number is a 7-digit number relating to your herd.

\*NZHA operates on 4 digit animal numbers. For example – Animal 'Mt Bruce Leonora 1' will show on NZHA paperwork as 'Mt Bruce Leonora 0001' likewise if it were to be numbered 10 or 0010, numbered 100 or 0100.
