0-30 days

Current Account

31-90 days

90 days & over

FULL BREEDING MEMBERSHIP

Any person taking an interest in Hereford cattle, or any company, or corporation INTENDING TO BREED HEREFORD CATTLE (or wishing to upgrade their NZHA membership), shall signify to the Council his or its desire to become a member, and who shall apply to become a member of the Association shall on approval by the Council, be admitted as a full breeding member and be entered on the Register of Members. An annual member shall pay on admission an Entrance Fee of \$575.00 GST inclusive and a subscription of \$330.00 GST inclusive and thereafter an annual subscription of \$330.00 GST inclusive or any other sum as the Council may from time to time prescribe. (Prospective Miniature Hereford Cattle breeders must apply for a full breeding membership of the NZ Hereford Association. Ensure the Miniature membership box is also selected.)

ASSOCIATE MEMBERSHIP

Any person, company or corporation taking an interest in Hereford cattle who shall signify to the Council his or its desire to become a member, and who shall apply to become a member of the Association and shall on approval by the Council, be admitted as an Associate Member and entered on the Register of Members. An Associate Member shall pay an annual subscription of \$57.50 GST inclusive or any such other sum as the Council may from time to time prescribe. (An Associate Member is unable to register cattle and shall not be entitled to vote an any meeting of the Association, nor to hold office in the Association, but shall receive regular newsletters, magazines and relevant information on the Association's activities.)

YOUTH MEMBERSHIP

A Youth Member is an individual of 10 years old to, that of, or under the age of 30, with an interest in Hereford cattle and has a maximum ownership of 10 female cattle admitted to the membership under Rule 2.3 and who or which has not ceased to be a Member under any other Rule. A Youth member shall pay an annual subscription of \$57.50 GST inclusive or any other sum as the Council may from time to time prescribe. A date of birth must be provided.

OVERSEAS MEMBERSHIP

Any person, company or corporation residing outside New Zealand intending to breed Hereford cattle or taking an interest in Hereford cattle. An overseas member shall pay an annual subscription of \$50.00 NZD or any such other sum as the Council may from time to time prescribe.
